ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as value declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI gained to peg the All - Share - Index at 97,520.54bps as against its previous close of at 97,064.42bps. This outing displayed a decrease of 0.47%

Market Capitalization followed suit the direction of the ASI to stand at N56.038tn, representing a 0.47% decrease from the N55.776tn it stood at the end of the previous trading.

Market activity as measured by the value of trades decreased in the session, with daily traded volume standing at 320,700,958units, representing a 19.49% increase from a volume of 268,394,149units traded in the previous session.

Value of those traded stocks decreased by -10.91% in the session to stand at N6,021,557,886.27 as against a N6,758,879,146.29 recorded in the previous trading session.
