ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as equity declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI lost to peg, the All - Share - Index at 98,023.23bps as against its previous close of at 98,058.07bps. This outing displayed a decrease of **-0.04%**

Market Capitalization followed suit the direction of the ASI to stand at N59.396tn, representing a **-0.04%** decrease from the N59.418tn it stood at the end of the previous trading.

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 538,956,267units, representing a **34.97%** increase from a volume of 399,324,907units traded in the previous session.

Value of those traded stocks increased by **71.43%** in the session to stand at N15,301,448,271.54 as against a N8,925,719,153.96 recorded in the previous trading session.
