ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as volume declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI gained to peg, the All - Share - Index at 97,972.33bps as against its previous close of at 97,747.27bps. This outing displayed an increase of 0.23%

Market Capitalization followed suit the direction of the ASI to stand at N59.366tn, representing a 0.23% increase from the N59.230tn it stood at the end of the previous trading.

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 333,948,810units, representing a -19.21% decrease from a volume 413,350,004units traded in the previous session.

Value of those traded stocks decreased by 20.33% in the session to stand at N6,421,298,218.15 as against a N5,336,321,823.13 recorded in the previous trading session.
