ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as volume, value and equity declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI lost to peg, the All - Share - Index at 98,107.52bps as against its previous close of at 98,210.75bps. This outing displayed a decrease of **-0.10%**

Market Capitalization followed suit the direction of the ASI to stand at N59.471tn, representing a **-0.10%** decrease from the N59.534tn it stood at the end of the previous trading.

Market activity as measured by the value of trades decreased in the session, with daily traded volume standing at 436,039,692units, representing a **-58.11%** increase from a volume 1,040,986,631units traded in the previous session.

Value of those traded stocks increased by **-26.33%** in the session to stand at N12,864,433,678.17 as against a N17,462,281,818.00 recorded in the previous trading session.
