ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as deals and value declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI gained to peg, the All - Share - Index at 98,206.97bps as against its previous close of at 98,107.52bps. This outing displayed an increase of **0.10%**

Market Capitalization followed suit the direction of the ASI to stand at N59.531tn, representing a **0.10%** increase from the N59.471tn it stood at the end of the previous trading.

Market activity as measured by the value of trades decreased in the session, with daily traded volume standing at 939,409,379units, representing a **115.44%** increase from a volume 436,039,692units traded in the previous session.

Value of those traded stocks decreased by **-0.39%** in the session to stand at N12,813,518,800.57 as against a N12,864,433,678.17 recorded in the previous trading session.
