ALL SHARE INDEX:

The Nigerian Equities Market witnessed an increase in trading activity today as deals, volume and value contribution increased, indicating positive outing to the trading session.

The NGXASI gained to peg, the All - Share - Index at 98,760.59bps as against its previous close of at 98,509.68bps. This outing displayed an increase of **0.25%**

Market Capitalization followed suit the direction of the ASI to stand at N59.867tn, representing a **0.25%** increase from the N59.715tn it stood at the end of the previous trading.

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 489,654,913 units, representing a **52.97%** increase from a volume 320,101,766 units traded in the previous session.

Value of those traded stocks increased by **8.94%** in the session to stand at N7,057,268,658.46 as against a N6,477,909,925.06 recorded in the previous trading session.
