## EQUITIES MARKET

### ALL SHARE INDEX:

The Nigerian Equities Market witnessed an increase in trading activity today as deals, volume and value contribution increased, indicating positive outing to the trading session.

The NGXASI gained to peg, the All - Share - Index at 99,922.63bps as against its previous close of at 99,378.06bps. This outing displayed an increase of **0.55%**

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 740,890,742units, representing a **36.13%** increase from a volume 544,235,224units traded in the previous session.

Value of those traded stocks increased by **58.75%** in the session to stand at N16,877,316,427.84 as against a N10,631,543,403.82 recorded in the previous trading session.
