ALL SHARE INDEX:

The Nigerian Equities Market witnessed a decrease in trading activity today as value declined, indicating subdued investor participation and a lack of significant market movement.

The NGXASI gained to peg, the All - Share - Index at 103,180.14bps as against its previous close of at 102,926.40bps. This outing displayed an increase of 0.25%

Market Capitalization followed suit the direction of the ASI to stand at N62.918tn, representing a 0.25% increase from the N62.763tn it stood at the end of the previous trading.

Market activity as measured by the value of trades decreased in the session, with daily traded volume standing at 829,754,438units, representing a 89.55% increase from a volume 437,758,859units traded in the previous session.

Value of those traded stocks decreased by -85.95% in the session to stand at N5,666,568,514.11 as against a N40,335,324,235.13 recorded in the previous trading session.
