The Nigerian Equities Market witnessed an increase in trading activity today as deals, volume and value contribution increased, indicating positive outing to the trading session.

The NGXASI gained to peg, the All - Share - Index at 102,370.36ps as against its previous close of at 102,353.68ps. This outing displayed an increase of 0.02%

Market Capitalization followed suit the direction of the ASI to stand at N62.861tn, representing a 0.02% increase from the N62.851tn it stood at the end of the previous trading.

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 1,326,041,719units, representing a 304.48% increase from a volume 327,839,118units traded in the previous session.

Value of those traded stocks increased by 49.62% in the session to stand at N17,666,570,084.39 as against a N11,807,849,367.06 recorded in the previous trading session.
