ALL SHARE INDEX:

Trading on the Nigerian Equities Market resumed today with investors taking varying positions on the bourse to capitalize on emerging opportunities.

At the end, NGX ASI dipped as the All - Share - Index finished at 103,958.75ps as against its previous close of at 104,418.95ps. This outing displayed a decrease of **-0.44%**

Market Capitalization followed suit the direction of the ASI to stand at N64.156tn, representing a **-0.44%** decrease from the N64.440tn it stood at the end of the previous trading.

Market activity as measured by the value of trades increased in the session, with daily traded volume standing at 542,229,692units, representing a **4.62%** increase from a volume 518,275,743units traded in the previous session.

Value of those traded stocks increased by **2.53%** in the session to stand at N13,636,085,330.08 as against a N13,299,389,690.91 recorded in the previous trading session.
