## EQUITIES MARKET

### ALL SHARE INDEX:

The market experienced some upward momentum with increased capitalization, AllShare-Index and trade count, although trading activity dropped with decline in volume and value.

A 13 basis point rise propelled the NGX ASI to 104,630.30 points, 0.13% higher than its previous value of 104,496.12 points.

In the same vein Market Capitalization posted N64.791tn, representing a 0.13% increase from the N64.708tn recorded at the end of the previous session.

The daily traded volume closed at 510,569,320 units, representing a -59.64% decrease from a volume 1,265,150,876 units traded in the previous session.

Value of traded stocks declined by -14.07% in the session to stand at N13, 253,118,347.08 as against a N15, 422,443,901.35 recorded in the previous trading session.
