ALL SHARE INDEX:

Still navigating the green territory but in a mixed trend, Market - wide Index and capitalization rose amidst declined trading activity, attesting to the resilience of the bourse even as investors thread with caution.

The All - Share - Index finished at 105,430.15 points, in contrast to the previous record of 105,324.89 points; representing 0.10% appreciation.

In the same vein, Market Capitalization climbed N65.287tn, moving 0.10% up from last session record of N65.221tn.

Conversely, daily traded volume dipped as volume nosedived to 537,188,094units, representing a -49.19% decrease from Wednesday's volume of 1,057,239,989units.

As a result, value of traded stocks dropped -20.08% in the session to close at N23, 025,259,563.05 as against N28, 812,231,747.98 recorded in the last session.
