ALL SHARE INDEX:

The All-Share Index (ASI) dipped 1.02%, while market capitalization also decreased, indicating a drop in market performance from trading activity despite increased trading volume and value.

The All - Share - Index finished at 108,053.95 points, in contrast to the previous record of 109,171.82 points; representing a 1.02% decrease.

While, Market Capitalization dropped N67.418tn, moving 1.02% downturn from the last session's record of N68.116tn.
