The equities market sustained the positive momentum, further narrowing the gap to the year's peak of 109,172.04, as investors' confidence grew amidst signs of increased profitability.

All - Share - Index (ASI) rallied 45 basis points, rising to 108,849.83 points from 108,361.10 points. In the same vein, market capitalization, climbed N68.412 trillion, up from N68.105 trillion.
