Profit – taking activity continued to impact the market, culminating in a mild 43 basis points loss, which drove the session into negative territory.

The All – Share – Index dipped, seeing a marginal decrease in trading activity, closing at 108,261.47. Market capitalization followed suit, decreasing to N68.042 trillion from N68.339 trillion, representing a loss of N297 billion.
