Today, the Nigerian bourse sustained the positive momentum. The market index gained 295.99 points to return to the 109,000 mark.

By the close of session, the All - Share - Index closed at 109,059.33 impacting Market capitalization which rose to N68.543 trillion from Tuesday's N68.358 trillion, as investors gained N185 billion.
