ALL SHARE INDEX:

A slight dip of 1 basis point in market performance impacted the Nigerian bourse, indicative of a mixed trend, as trading activity gained momentum despite the marginal decline in performance.

By the end of the session, the All - Share - Index was pegged at 109,697.83, while Market Capitalization settled at N68.945 trillion losing N7.89 billion to investors' wealth.
