In a quick rebound, the market index rallied 3 basis points, navigating into green territory to recover from yesterday's mild downturn, showcasing the resilience demonstrated by investors.

By the end of the session, the All - Share - Index was pegged at 109,730.47, while Market Capitalization settled at N68.965 trillion gaining N20 billion to investors' wealth.
