Profit – taking activity continued to impact the market, dragging it into a marginal loss amidst clear sector rotation and elevated market activity, as investors continue to consolidate their positions.

By the end of the session, the All – Share – Index was pegged at 109,183.02, while Market Capitalization settled at N68.621 trillion, losing N20 billion to investors' wealth.
