ALL SHARE INDEX:

The stock market soared to a new all – time high, reaching a record – breaking index level of 111,606.22. This milestone, fueled by impressive market action and positive investor sentiment, marks a significant achievement in the market's history.

The All – Share Index rallied 157 basis points, impacting Market Capitalization, which rose marginally, closing at N70,377 trillion, as investors' wealth gained N1,086 billion.
