### ALL SHARE INDEX:

The stock market Index continued its momentum, seeing a marginal increase in trading activity, and consolidated its position above the 110,000 mark, reaching 111,902.61.

The All - Share Index rallied 27 basis points, driving a marginal increase in Market Capitalization, which closed at N70,564 trillion, with investors' wealth surging by N187 billion.
