Today, moderate profit – taking by investors led to a decline, with the index dropping 84.53 points to close at 111,818.08, representing an 8% basis points decrease.

The All – Share Index slipped, driving a marginal decrease in Market Capitalization, which closed at N70,510 trillion, with investors' wealth falling by N54 billion.
