Profit – taking activity continued to impact the equities market, with the index slipping 76.07 points to close at 111,742.01, representing a 7% basis points decrease.

The All – Share Index slipped, driving a marginal decrease in Market Capitalization, which closed at N70,462 trillion, with investors' wealth falling by N48 billion.
