### ALL SHARE INDEX:

The market started the week on a positive note as the index rose 273.94 points to close at 112,015.95, representing a 25 basis point increase.

The All - Share Index rose, driving a marginal increase in Market Capitalization, which closed at N70,635 trillion, with investors' wealth rising by N173 billion.
