### ALL SHARE INDEX:

The Nigerian bourse maintained its upward momentum, as the index rose 411.53 points to close at 112,427.48, representing a 37 basis point increase.

The All - Share Index rose, driving a marginal increase in Market Capitalization, which closed at N70,894 trillion, with investors' wealth rising by N259 billion.
