ALL SHARE INDEX:

The Nigerian bourse ended the day on a positive note as the NGX ASI rose 0.56% to 114,659.11, adding N405 billion to Market Capitalization. Although the market ended the day with more decliners than gainers, as 37 stocks lost value while 34 stocks gained, some notable stocks (MTNN, DANGCEM, and others) contributed to the market's movement.

By the end of the session, Market Capitalization closed at N72.302 trillion, up from N71.897 trillion.
