The Nigerian bourse ended the week on a positive note as the NGX ASI rose 0.67% to 115,429.54, adding N486 billion to Market Capitalization.

The sustained momentum pushed the ASI to a new high, impacting Market Capitalization, which closed at N72.788 trillion, up from N72.302 trillion.
