## **ALL SHARE INDEX:**

In a quick rebound, the market index rallied 163 basis points, navigating into green territory to recover from yesterday's mild downturn, showcasing the resilience demonstrated by investors.

The All – Share – Index rose by 1,876.71 points to close at 116,786.87. This resulted in a N1,184 billion increase in Market Capitalization to post N73.681 trillion, up from N72.497 trillion, reflecting an increase in investors' wealth.
