In a remarkable feat, the index jumped 91 basis points, reaching new heights on the back of growing investor confidence.

The All - Share - Index rose by 1,074.26 points to close at 117,861.13, resulting in a N677 billion increase in Market Capitalization to N74.358 trillion from N73.681 trillion, reflecting an increase in investors' wealth.
