### ALL SHARE INDEX:

The Nigerian equities market started the week on a positive note, with the NGX ASI rising by 441.43 points, gaining 37 basis points to close at 118,579.65. This resulted in a N279 billion increase in Market Capitalization, reflecting an increase in investors' wealth.

The Market Capitalization closed at N74.812 trillion, up from N74.533 trillion.
