The Nigerian stock market extended its bullish trend, with the NGX All – Share Index advancing by 1,211.73 points, representing a 1.02% gain to close at 119,790.82.

Consequently, the total Market Capitalization appreciated by N764 billion, indicating a significant rise in investor wealth. which closed at N75.576 trillion, up from N74.812 trillion.
