The session ended with the market down 776.92 points, driven by lighter trading volumes than seen in the previous session.

The All - Share - Index (ASI) dropped 64 basis points declining to 119,995.76 from 120,772.68, as Market Capitalization shed N491 billion, closing at N75.962 trillion.
