The Nigerian bourse extended its positive run into the week, gaining 43 basis points to settle at 126,689.54, buoyed by strong investor interest.

The Nigerian bourse closed in positive territory, with the benchmark All - Share - Index (ASI) rising by 538.50 points from 126,151.04, translating to a N340 billion boost in market capitalization to N80.143 trillion.
