ALL SHARE INDEX:

The bullish momentum continued on the local bourse, with the index climbing 180 basis points to hit a new high of 128,967.08, breaching the 126,000 mark on the back of rising investor confidence.

Strong investor appetite pushed the All - Share - Index (ASI) up by 2,277.54 points, resulting in a N1,441 trillion increase in market capitalization to N81.584 trillion.
