ALL SHARE INDEX:

The market's bullish tone endured, with an 8 basis point gain, as the All – Share – Index's persistent growth and wider market resilience continued to reflect strengthening investor sentiment.

The uptrend continued as the All – Share – Index (ASI) rose by 105.7 points, settling at 132,557.43. Market capitalization also advanced, climbing N67 billion to reach N83.856 trillion.
