#### **ALL SHARE INDEX:**

The Nigerian bourse added 48 basis points for the fourth consecutive session, driven by continued strength in the All – Share – Index and broader market resilience – mirroring rising investor optimism.

The All - Share - Index (ASI) climbed a further 642.56 points to 133,199.99, reflecting the sustained uptrend, while market capitalization improved by N406 billion to N84.262 trillion.
