Closing the week on a strong footing, the Nigerian bourse appreciated by 94 basis points, marking five consecutive sessions of positive performance and preserving its bullish course.

Reflecting continued investor interest, the All – Share – Index (ASI) increased by 1,252.94 points to 134,452.93, as market capitalization jumped by N793 billion to N85.055 trillion.
