## EQUITIES MARKET

### ALL SHARE INDEX:

The equities market pushed further into positive territory, adding 12 basis points. Widespread buying interest lifted market breadth, reflecting investors' renewed appetite for equities.

Equities finished the day stronger, with the All – Share – Index up by 175.12 point at 146,055.89 and market capitalization improving by N111 billion to settle at N92.405 trillion.
