### ALL SHARE INDEX:

Today, moderate profit – taking by investors led to a decline, with the index dropping, representing a 13% basis points decrease.

Equities slipped, with the All – Share – Index down by 191.09 point at 145,864.80 and market capitalization dropping by N121 billion to settle at N92.284 trillion.
