Profit – taking momentum extended into the session, cutting the index by 564.79 points to finish at 145,300.01, reflecting a 39 basis points dip.

The session closed with the All – Share Index down, pulling Market Capitalization down to N91.926 trillion and wiping N358 billion from overall market value.
