The market kicked off the week in positive territory as the benchmark index appreciated by 94.27 points to close at 144,722.47, up 7 basis points.

A mild uptick in the All – Share Index spurred market capitalization higher to N91.561 trillion, translating to a N60 billion gain in investors' value.
