ALL SHARE INDEX:

Recovering from earlier setbacks, the All – Share – Index jumped 671.70 points to settle at 141,004.14, securing a green close for the week.

Riding on firmer market sentiment, the All – Share – Index (ASI) closed 0.48% higher at 140,332.44 points, accompanied by a similar 0.48% gain in market capitalization to N89.208 trillion.
