ALL SHARE INDEX:

The trading week opened on a strong note as the All – Share – Index advanced by 31 basis points, with improving market breadth signalling renewed investor optimism and a bullish tone.

The bullish run continued as the All – Share – Index (ASI) advanced 435.63 points to close at 141,439.77, up from 141,004.14 in the previous session. In tandem, market capitalization grew by N285 billion to settle at N89.493 trillion.
