## **EQUITIES MARKET**

#### **ALL SHARE INDEX:**

The benchmark index declined by 691.52 points to 140,557.24, representing a 0.49% retreat, as the market lost N438 billion in capitalization, reducing investor wealth.

Following the dip in the index, the equities market recorded a mild contraction in capitalization, settling at N88.934 trillion, lower than N89.372 trillion earlier.
