The benchmark index recorded a 0.67% fall, sliding 941.64 points to 138,780.55, as investors engaged in profit – taking. Market Capitalization followed suit, shrinking by N596 billion.

Consequent to the losses, Market Capitalization closed lower at N87.810 trillion, down from N88.406 trillion.
