The session closed upbeat, with the NGX All-Share Index (ASI) advancing by 822.85 points to 138,980.01, translating to a 0.60% increase, while Market Capitalization closed higher at N520 billion.

At market close, the Market Capitalization level rose to N87.936 trillion, reflecting growth from N87.416 trillion.
