### ALL SHARE INDEX:

The positive movement of the All – Share Index demonstrates widespread equity gains, and the concurrent rise in Market Capitalization reveals stronger investor morale and market expansion.

With gains continuing, the All – Share – Index climbed 0.21% to settle at 140,665.84 points, while Market Capitalization also appreciated 0.21%, closing higher at N89.003 trillion.
