The Nigerian Equities Market pushed further upward, as the index climbed 41 basis points to record another high, with the corresponding rise in Market Capitalization pointing to firmer investor optimism and enhanced market value.

The All - Share - Index appreciated by 569.25 points to finish at 140,365.36, lifting Market Capitalization by N360 billion to N88.813 trillion and enhancing investor fortunes.
