Investors welcomed the new week with gains, as the NGX ASI added 1,113.31 points, gaining 79 basis points, to close at 141,659.00. This upward movement pushed Market Capitalization higher by N704 billion.

The session closed with Market Capitalization firming up at N89.626 trillion, a gain from N88.922 trillion.
