ALL SHARE INDEX:

The market staged a swift recovery as the index climbed 35 basis points, reversing the previous session's slight dip and reflecting investors' resilience.

The NGX All – Share – Index advanced by 489.43 points, closing at 142,036.23, while Market Capitalization grew by N310 billion to settle at N89.865 trillion, indicating a boost in investors' wealth.
